The greatest strength of Gemeinnützige Wohnungsbaugesellschaft der Stadt Kassel mit Beschränkter Haftung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 74% points. The greatest weakness of Gemeinnützige Wohnungsbaugesellschaft der Stadt Kassel mit Beschränkter Haftung is the variable Operating Result Tc, reducing the Economic Capital Ratio by 303% points.

The company's Economic Capital Ratio, given in the ranking table, is 74%, being 56% points below the market average of 130%.
