



The relative strengths and weaknesses of Katholisches Wohnungsbau und Siedlungswerk der Diözese Regensburg GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Katholisches Wohnungsbau und Siedlungswerk der Diözese Regensburg GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 58% points. The greatest weakness of Katholisches Wohnungsbau und Siedlungswerk der Diözese Regensburg GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 280% points.

The company's Economic Capital Ratio, given in the ranking table, is 58%, being 72% points below the market average of 130%.
