The greatest strength of Rostocker Gesellschaft für Stadterneuerung Stadtentwicklung und Wohnungsbau mit Beschränkter Haftung compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Care Remainder, increasing the Economic Capital Ratio by 112% points. The greatest weakness of Rostocker Gesellschaft für Stadterneuerung Stadtentwicklung und Wohnungsbau mit Beschränkter Haftung is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, reducing the Economic Capital Ratio by 179% points.

The company's Economic Capital Ratio, given in the ranking table, is 169%, being 38% points above the market average of 130%.
