The greatest strength of Wirtschaftsförderungs und Wohnungsbau Gesellschaft m b H der Stadt Königswinter compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 70% points. The greatest weakness of Wirtschaftsförderungs und Wohnungsbau Gesellschaft m b H der Stadt Königswinter is the variable Operating Result Tc, reducing the Economic Capital Ratio by 302% points.

The company's Economic Capital Ratio, given in the ranking table, is 70%, being 60% points below the market average of 130%.
