

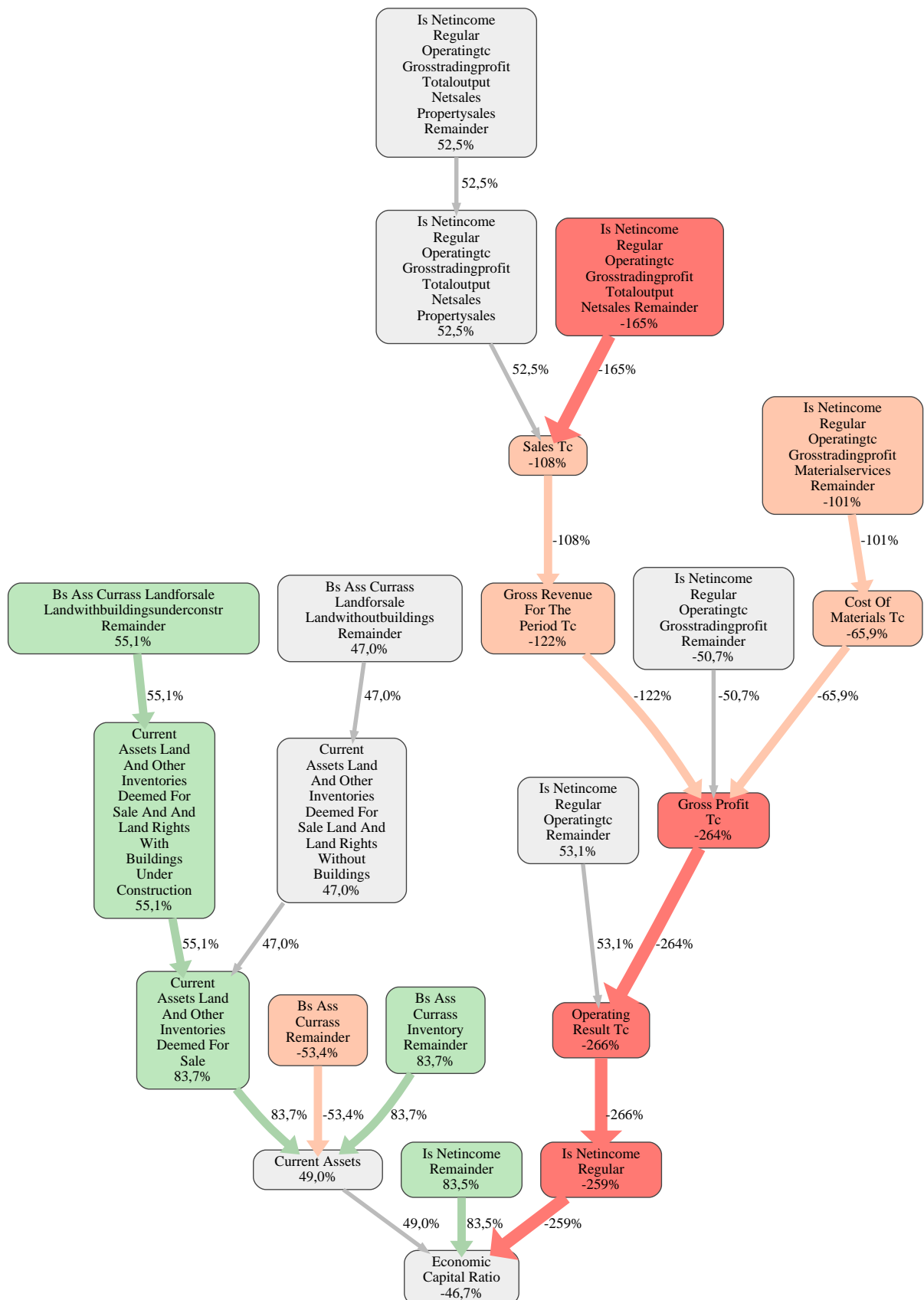

The relative strengths and weaknesses of Stuckert Wohnbau Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Stuckert Wohnbau Aktiengesellschaft compared to the market average is the variable Bs Ass Currass Inventory Remainder, increasing the Economic Capital Ratio by 84% points. The greatest weakness of Stuckert Wohnbau Aktiengesellschaft is the variable Operating Result Tc, reducing the Economic Capital Ratio by 266% points.

The company's Economic Capital Ratio, given in the ranking table, is 84%, being 47% points below the market average of 130%.
