



The relative strengths and weaknesses of Takenaka Europe GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Takenaka Europe GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 59% points. The greatest weakness of Takenaka Europe GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 222% points.

The company's Economic Capital Ratio, given in the ranking table, is 59%, being 71% points below the market average of 130%.
