

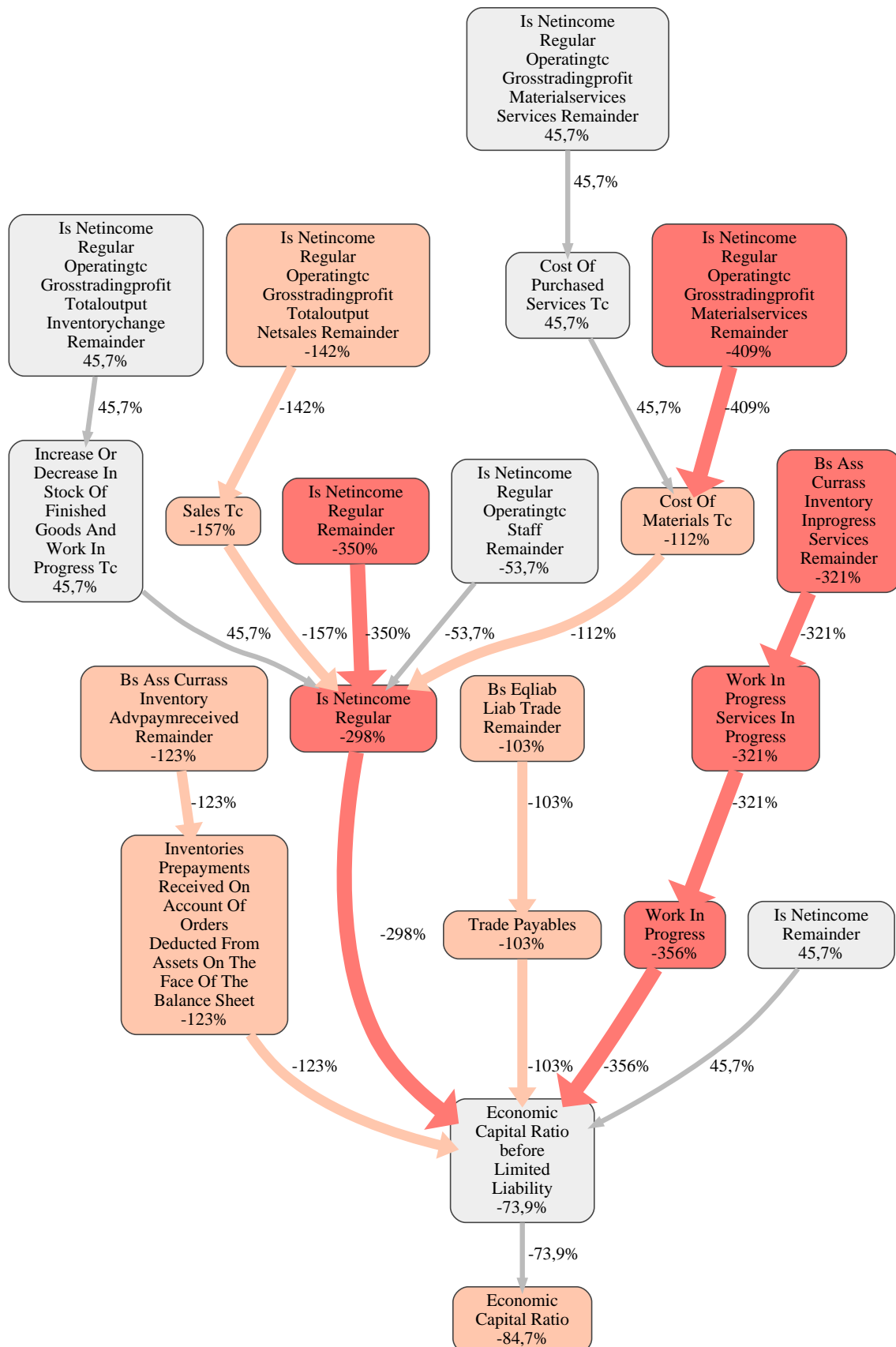

The greatest strength of ZECH Sports GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Inventorychange Remainder, increasing the Economic Capital Ratio by 46% points. The greatest weakness of ZECH Sports GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, reducing the Economic Capital Ratio by 409% points.

The company's Economic Capital Ratio, given in the ranking table, is 46%, being 85% points below the market average of 130%.
