

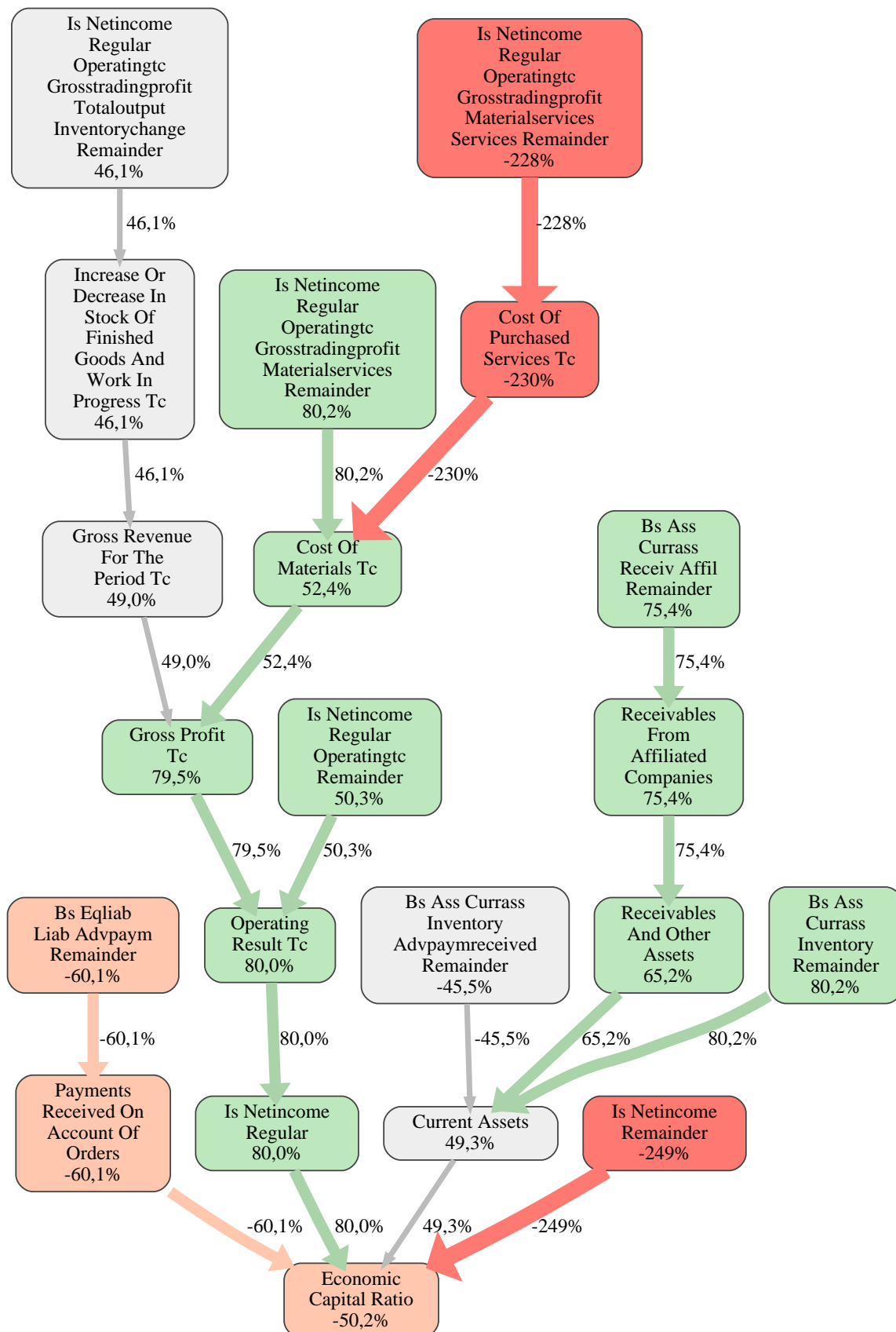

The relative strengths and weaknesses of BB Government Services GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BB Government Services GmbH compared to the market average is the variable Bs Ass Currass Inventory Remainder, increasing the Economic Capital Ratio by 80% points. The greatest weakness of BB Government Services GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 249% points.

The company's Economic Capital Ratio, given in the ranking table, is 80%, being 50% points below the market average of 130%.
