



The relative strengths and weaknesses of Heinz Schnorpfeil Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Heinz Schnorpfeil Bau GmbH compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 157% points. The greatest weakness of Heinz Schnorpfeil Bau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 482% points.

The company's Economic Capital Ratio, given in the ranking table, is 157%, being 27% points above the market average of 130%.
