



The relative strengths and weaknesses of Let Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Let Bau GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 118% points. The greatest weakness of Let Bau GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 320% points.

The company's Economic Capital Ratio, given in the ranking table, is 118%, being 12% points below the market average of 130%.
