



The relative strengths and weaknesses of PORR Oevermann GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of PORR Oevermann GmbH compared to the market average is the variable Is Netincome Regular Fin Netparticipation Earningprofsharing Remainder, increasing the Economic Capital Ratio by 66% points. The greatest weakness of PORR Oevermann GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 324% points.

The company's Economic Capital Ratio, given in the ranking table, is 120%, being 11% points below the market average of 130%.
