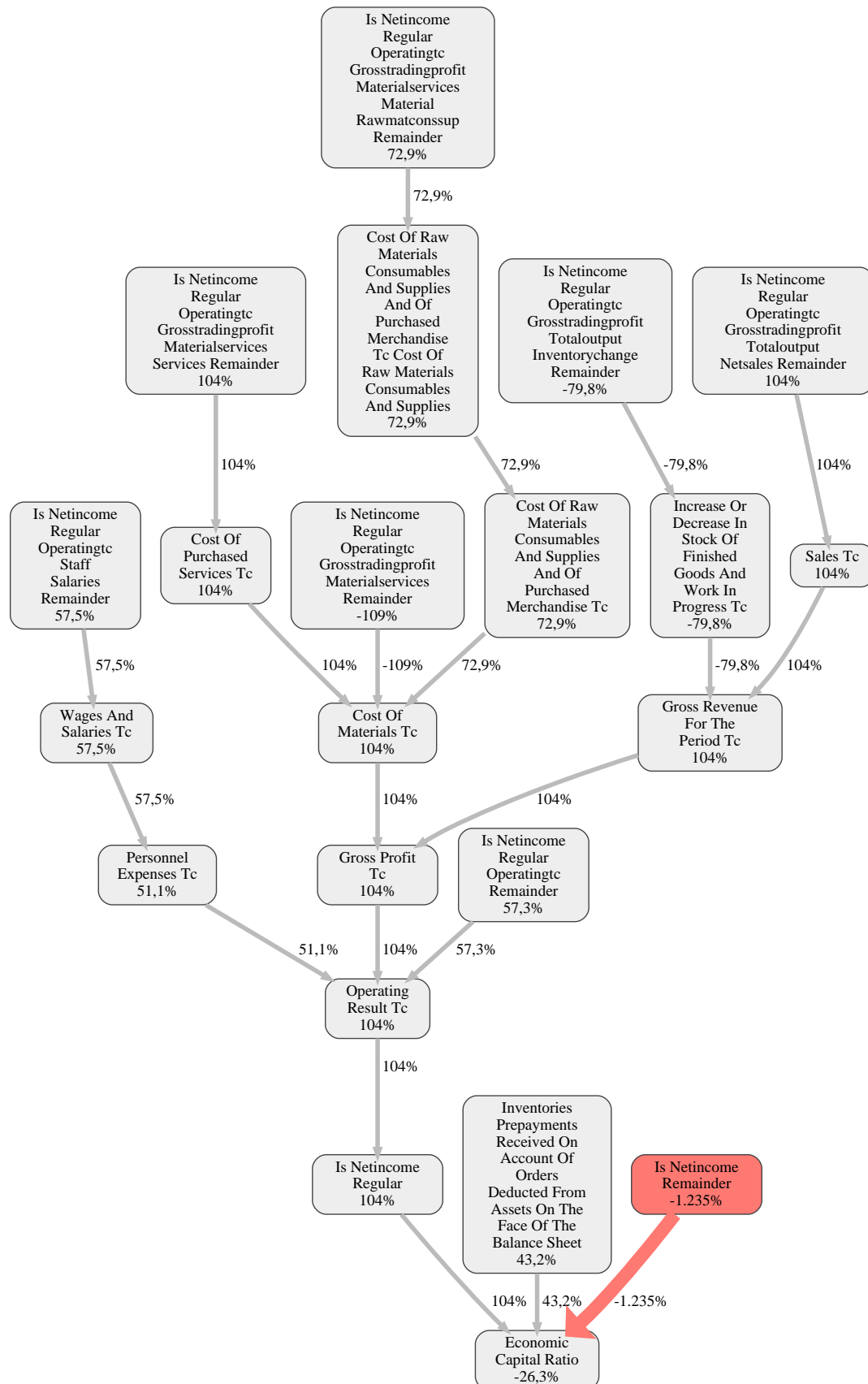

The greatest strength of Mainka Bau GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, increasing the Economic Capital Ratio by 104% points. The greatest weakness of Mainka Bau GmbH Co KG is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 1.235% points.

The company's Economic Capital Ratio, given in the ranking table, is 104%, being 26% points below the market average of 130%.
