



The relative strengths and weaknesses of Gebr Nicklaus GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gebr Nicklaus GmbH compared to the market average is the variable Stockholders Equity, increasing the Economic Capital Ratio by 144% points. The greatest weakness of Gebr Nicklaus GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 86% points.

The company's Economic Capital Ratio, given in the ranking table, is 234%, being 104% points above the market average of 130%.
