



The relative strengths and weaknesses of Echterhoff Holding GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Echterhoff Holding GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 132% points. The greatest weakness of Echterhoff Holding GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 321% points.

The company's Economic Capital Ratio, given in the ranking table, is 132%, being 1,9% points above the market average of 130%.
