



The relative strengths and weaknesses of Porr Industriebau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Porr Industriebau GmbH compared to the market average is the variable Work In Progress, increasing the Economic Capital Ratio by 88% points. The greatest weakness of Porr Industriebau GmbH is the variable Bs Ass Currass Inventory Inprogress Remainder, reducing the Economic Capital Ratio by 1.525% points.

The company's Economic Capital Ratio, given in the ranking table, is 88%, being 43% points below the market average of 130%.
