



The relative strengths and weaknesses of Josef Rädlinger Kiesbaggerei und Fuhrunternehmen GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Josef Rädlinger Kiesbaggerei und Fuhrunternehmen GmbH Co KG compared to the market average is the variable Inventories Prepayments Received On Account Of Orders Deducted From Assets On The Face Of The Balance Sheet, increasing the Economic Capital Ratio by 47% points. The greatest weakness of Josef Rädlinger Kiesbaggerei und Fuhrunternehmen GmbH Co KG is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 138% points.

The company's Economic Capital Ratio, given in the ranking table, is 75%, being 55% points below the market average of 130%.
