



The relative strengths and weaknesses of Dobler Gesellschaft mit Beschränkter Haftung Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Dobler Gesellschaft mit Beschränkter Haftung Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 129% points. The greatest weakness of Dobler Gesellschaft mit Beschränkter Haftung Konzern is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 651% points.

The company's Economic Capital Ratio, given in the ranking table, is 129%, being 1,8% points below the market average of 130%.
