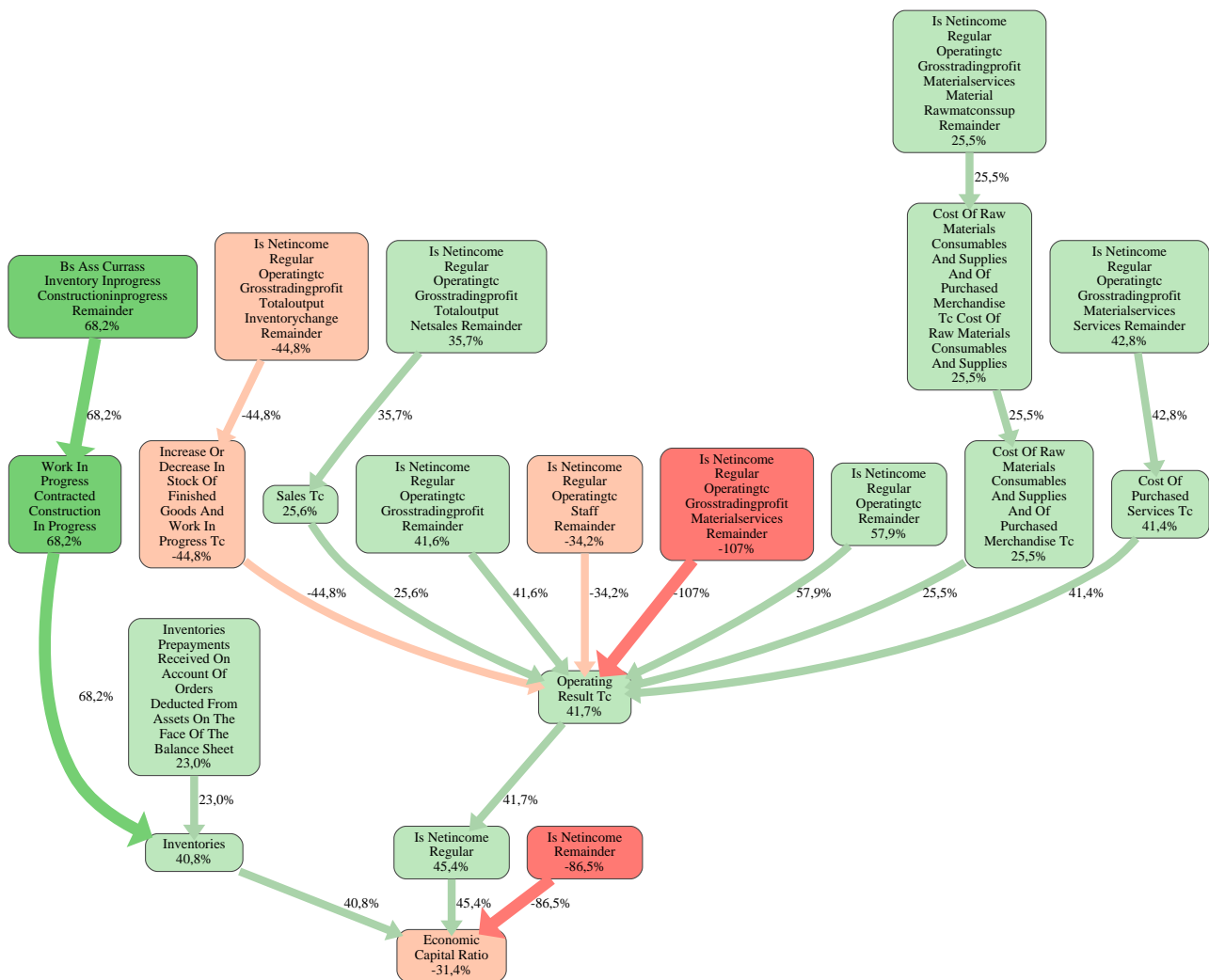

The greatest strength of Krämmel Gesellschaft mit Beschränkter Haftung Konzern compared to the market average is the variable Bs Ass Currass Inventory Inprogress Constructioninprogress Remainder, increasing the Economic Capital Ratio by 68% points. The greatest weakness of Krämmel Gesellschaft mit Beschränkter Haftung Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, reducing the Economic Capital Ratio by 107% points.

The company's Economic Capital Ratio, given in the ranking table, is 99%, being 31% points below the market average of 130%.
