The greatest strength of Joachim Nessler Geschäftsführungsgesellschaft mbh Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, increasing the Economic Capital Ratio by 173% points. The greatest weakness of Joachim Nessler Geschäftsführungsgesellschaft mbh Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 443% points.

The company's Economic Capital Ratio, given in the ranking table, is 173%, being 43% points above the market average of 130%.
