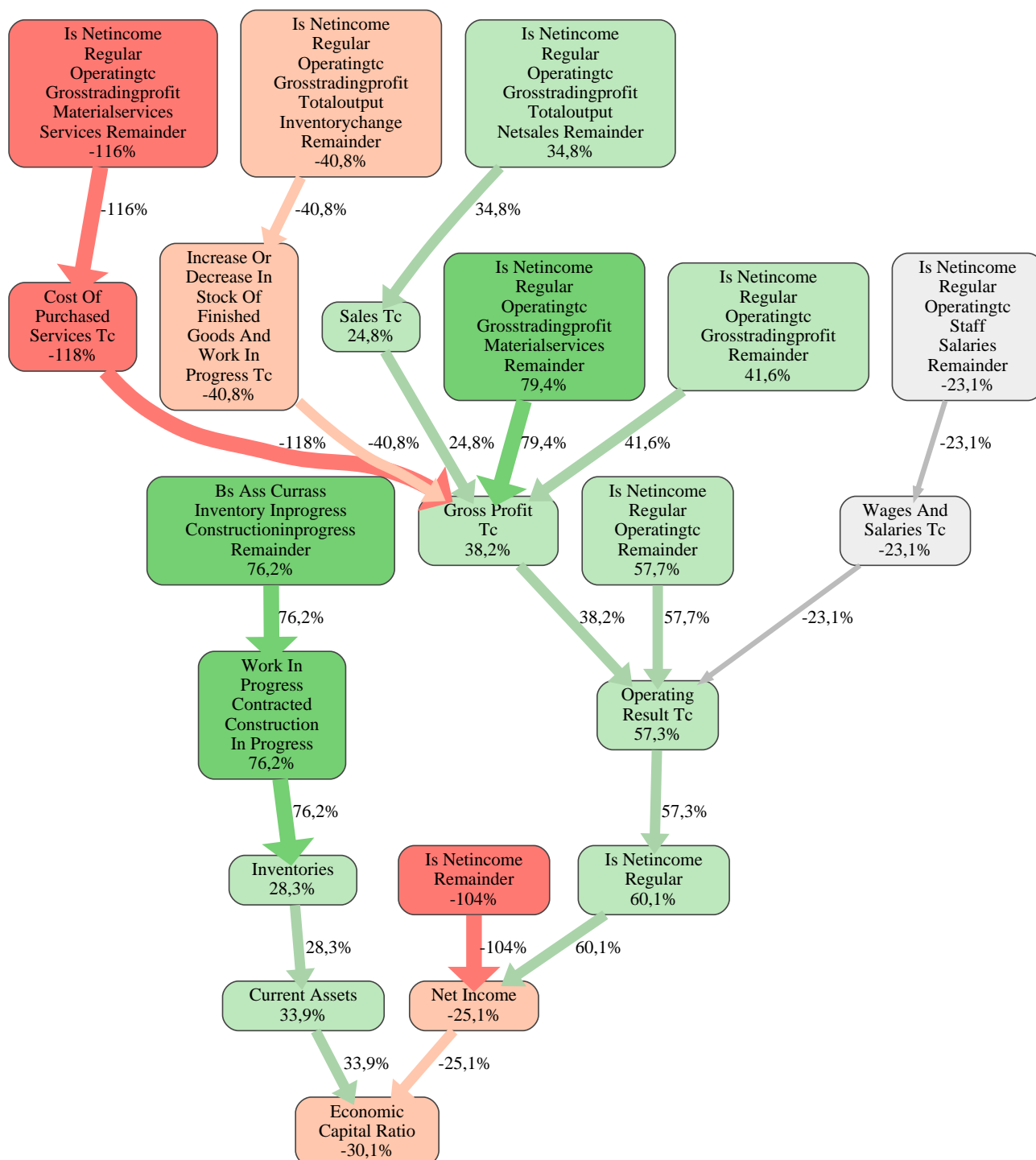

The greatest strength of Otto Wulff Bauunternehmung GmbH Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 79% points. The greatest weakness of Otto Wulff Bauunternehmung GmbH Konzern is the variable Cost Of Purchased Services Tc, reducing the Economic Capital Ratio by 118% points.

The company's Economic Capital Ratio, given in the ranking table, is 100%, being 30% points below the market average of 130%.
