



The relative strengths and weaknesses of Dipl Ing Emil Hönninger GmbH Co Bauunternehmung KG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Dipl Ing Emil Hönninger GmbH Co Bauunternehmung KG Konzern compared to the market average is the variable Bs Ass Currass Inventory Inprogress Remainder, increasing the Economic Capital Ratio by 814% points. The greatest weakness of Dipl Ing Emil Hönninger GmbH Co Bauunternehmung KG Konzern is the variable Bs Eqliab Liab Advpaym Remainder, reducing the Economic Capital Ratio by 171% points.

The company's Economic Capital Ratio, given in the ranking table, is 814%, being 684% points above the market average of 130%.
