



The relative strengths and weaknesses of H E Holding GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of H E Holding GmbH Konzern compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 168% points. The greatest weakness of H E Holding GmbH Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 417% points.

The company's Economic Capital Ratio, given in the ranking table, is 168%, being 38% points above the market average of 130%.
