The greatest weakness of Lebenshilfe Bayern Mitte GmbH Vormals Lebenshilfe Werkstätten der Region 10 Gesellschaft mit Beschränkter Haftung is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 150% points.

The company's Economic Capital Ratio, given in the ranking table, is 183%, being 53% points above the market average of 130%.
