



The relative strengths and weaknesses of B O Bau GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of B O Bau GmbH Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 145% points. The greatest weakness of B O Bau GmbH Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 788% points.

The company's Economic Capital Ratio, given in the ranking table, is 145%, being 15% points above the market average of 130%.
