



The relative strengths and weaknesses of H E Holding GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of H E Holding GmbH compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 350% points. The greatest weakness of H E Holding GmbH is the variable Bs Ass Fixass Fin Remainder, reducing the Economic Capital Ratio by 3.339% points.

The company's Economic Capital Ratio, given in the ranking table, is 350%, being 219% points above the market average of 130%.
