



The relative strengths and weaknesses of Derichs u Konertz GmbH u Co KG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Derichs u Konertz GmbH u Co KG Konzern compared to the market average is the variable Bs Ass Currass Inventory Inprogress Remainder, increasing the Economic Capital Ratio by 82% points. The greatest weakness of Derichs u Konertz GmbH u Co KG Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 431% points.

The company's Economic Capital Ratio, given in the ranking table, is 82%, being 49% points below the market average of 130%.
