



The relative strengths and weaknesses of Josef Meier GmbH Co KG Hoch und Tiefbau Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Josef Meier GmbH Co KG Hoch und Tiefbau Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Staff Remainder, increasing the Economic Capital Ratio by 47% points. The greatest weakness of Josef Meier GmbH Co KG Hoch und Tiefbau Konzern is the variable Cost Of Materials Tc, reducing the Economic Capital Ratio by 48% points.

The company's Economic Capital Ratio, given in the ranking table, is 75%, being 56% points below the market average of 130%.
