



The relative strengths and weaknesses of Nesslerer bau gmbh are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Nesslerer bau gmbh compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 116% points. The greatest weakness of Nesslerer bau gmbh is the variable Work In Progress, reducing the Economic Capital Ratio by 3.861% points.

The company's Economic Capital Ratio, given in the ranking table, is 116%, being 15% points above the market average of 102%.
