

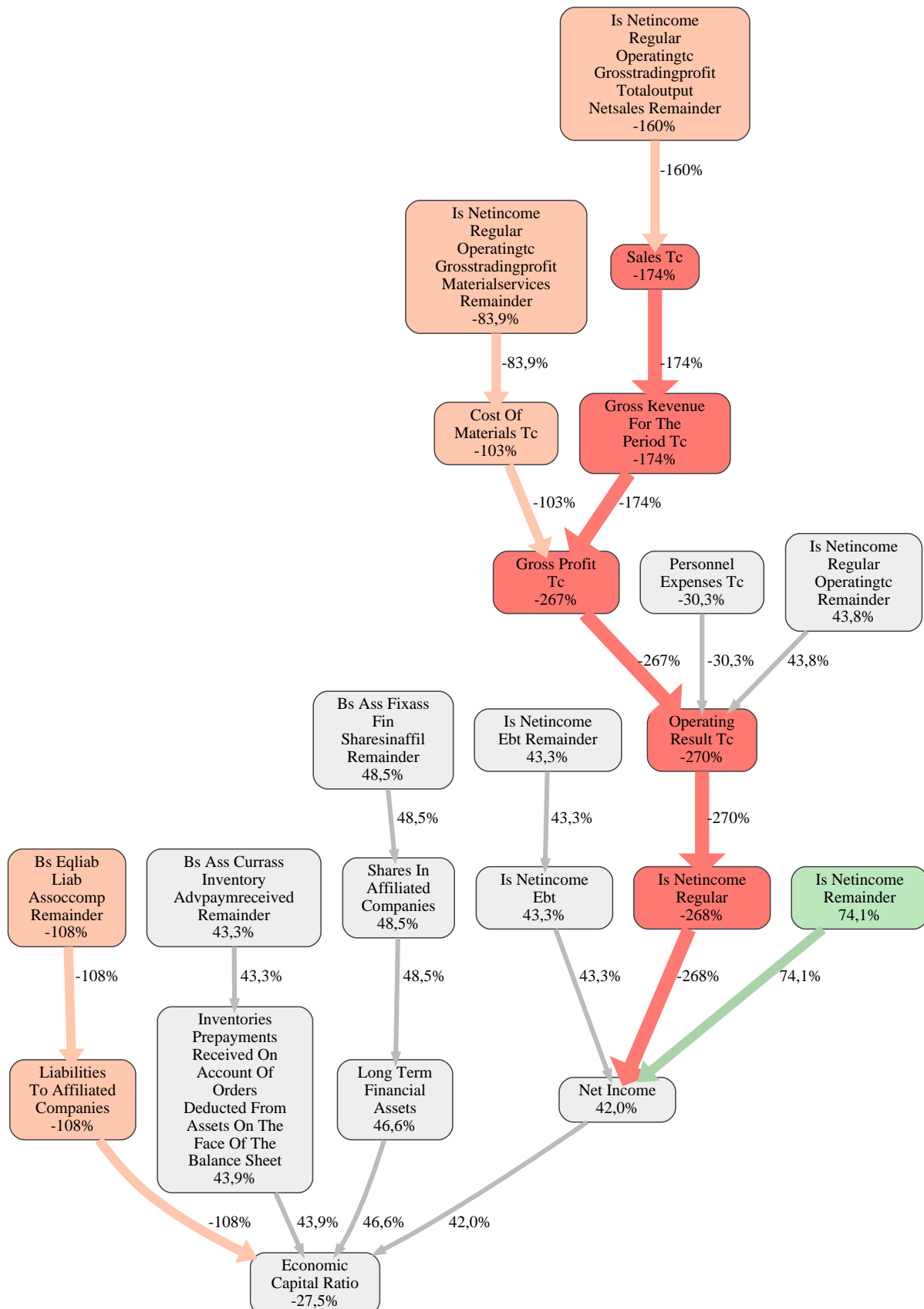

The relative strengths and weaknesses of Ortwin Goldbeck Holding SE are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ortwin Goldbeck Holding SE compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 74% points. The greatest weakness of Ortwin Goldbeck Holding SE is the variable Operating Result Tc, reducing the Economic Capital Ratio by 270% points.

The company's Economic Capital Ratio, given in the ranking table, is 74%, being 28% points below the market average of 102%.
