



The relative strengths and weaknesses of B O Bau und Gebäudetechnik GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of B O Bau und Gebäudetechnik GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 65% points. The greatest weakness of B O Bau und Gebäudetechnik GmbH Co KG is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 952% points.

The company's Economic Capital Ratio, given in the ranking table, is 65%, being 37% points below the market average of 102%.
