



The relative strengths and weaknesses of VSTR AG Rodewisch are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of VSTR AG Rodewisch compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 110% points. The greatest weakness of VSTR AG Rodewisch is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 557% points.

The company's Economic Capital Ratio, given in the ranking table, is 110%, being 8,1% points above the market average of 102%.
