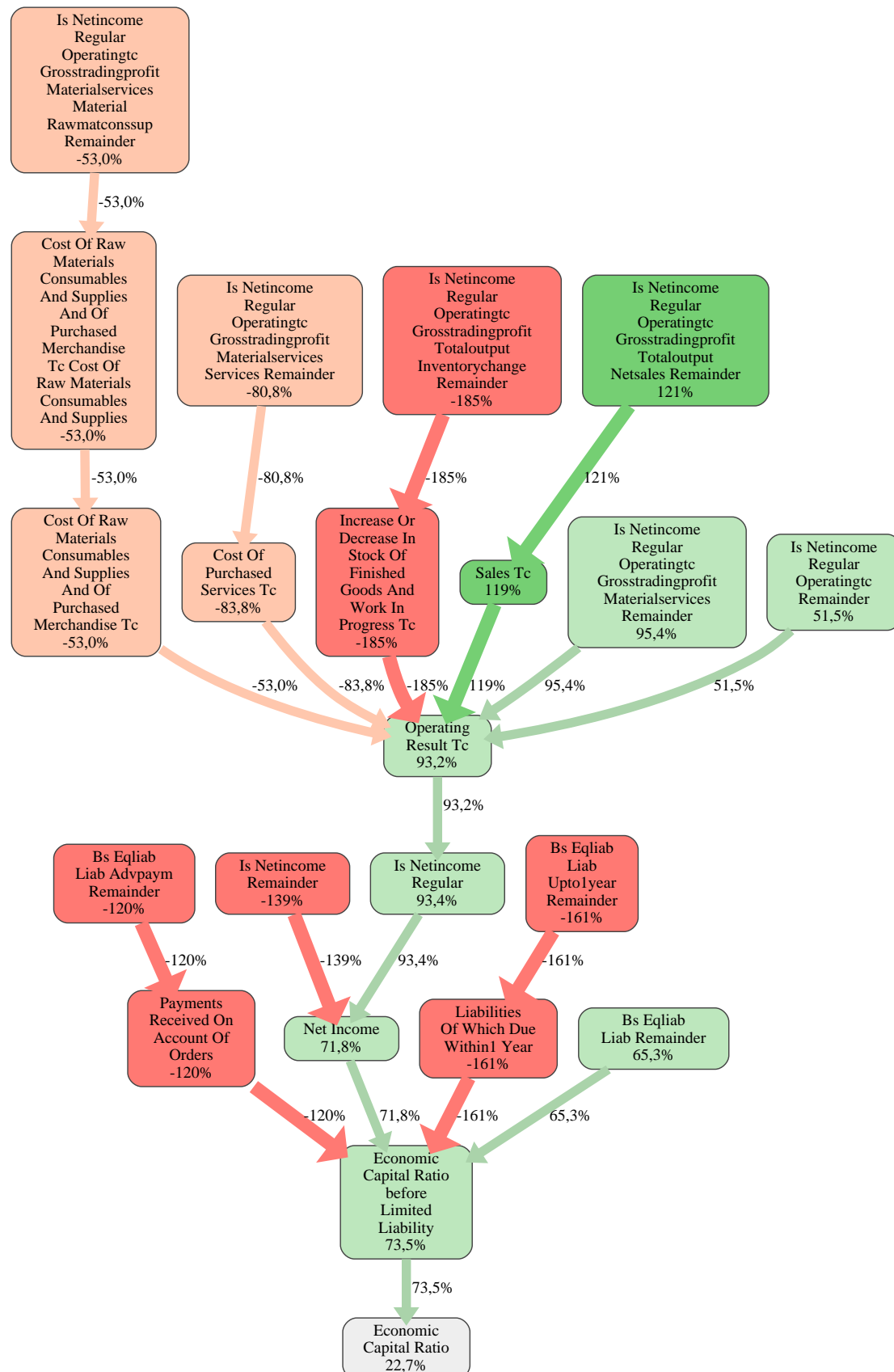

The relative strengths and weaknesses of Krüger Bau Bernau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Krüger Bau Bernau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, increasing the Economic Capital Ratio by 121% points. The greatest weakness of Krüger Bau Bernau GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Inventorychange Remainder, reducing the Economic Capital Ratio by 185% points.

The company's Economic Capital Ratio, given in the ranking table, is 124%, being 23% points above the market average of 102%.
