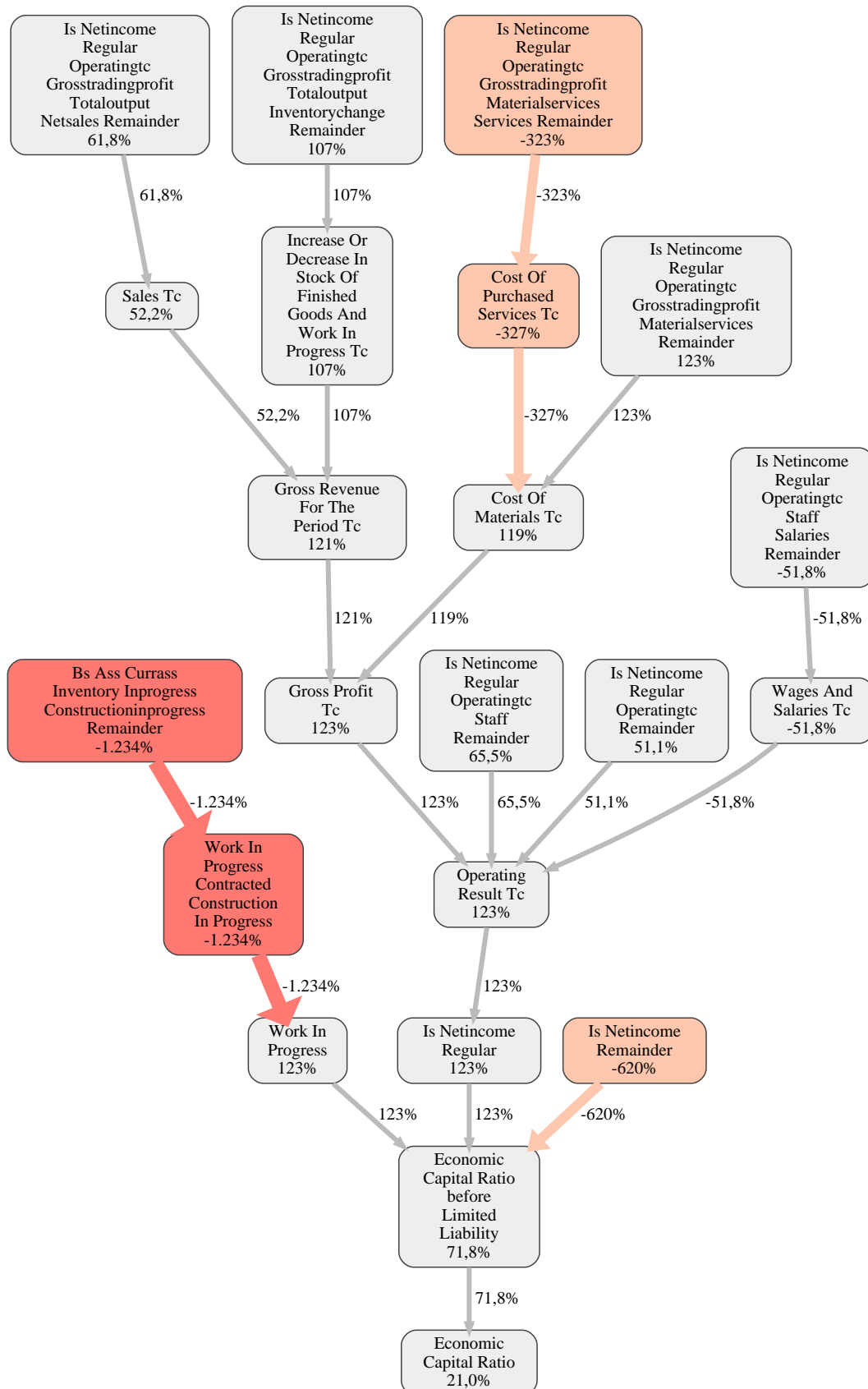

The relative strengths and weaknesses of Otto Wulff Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Otto Wulff Bauunternehmung GmbH compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 123% points. The greatest weakness of Otto Wulff Bauunternehmung GmbH is the variable Bs Ass Currass Inventory Inprogress Constructioninprogress Remainder, reducing the Economic Capital Ratio by 1.234% points.

The company's Economic Capital Ratio, given in the ranking table, is 123%, being 21% points above the market average of 102%.
