

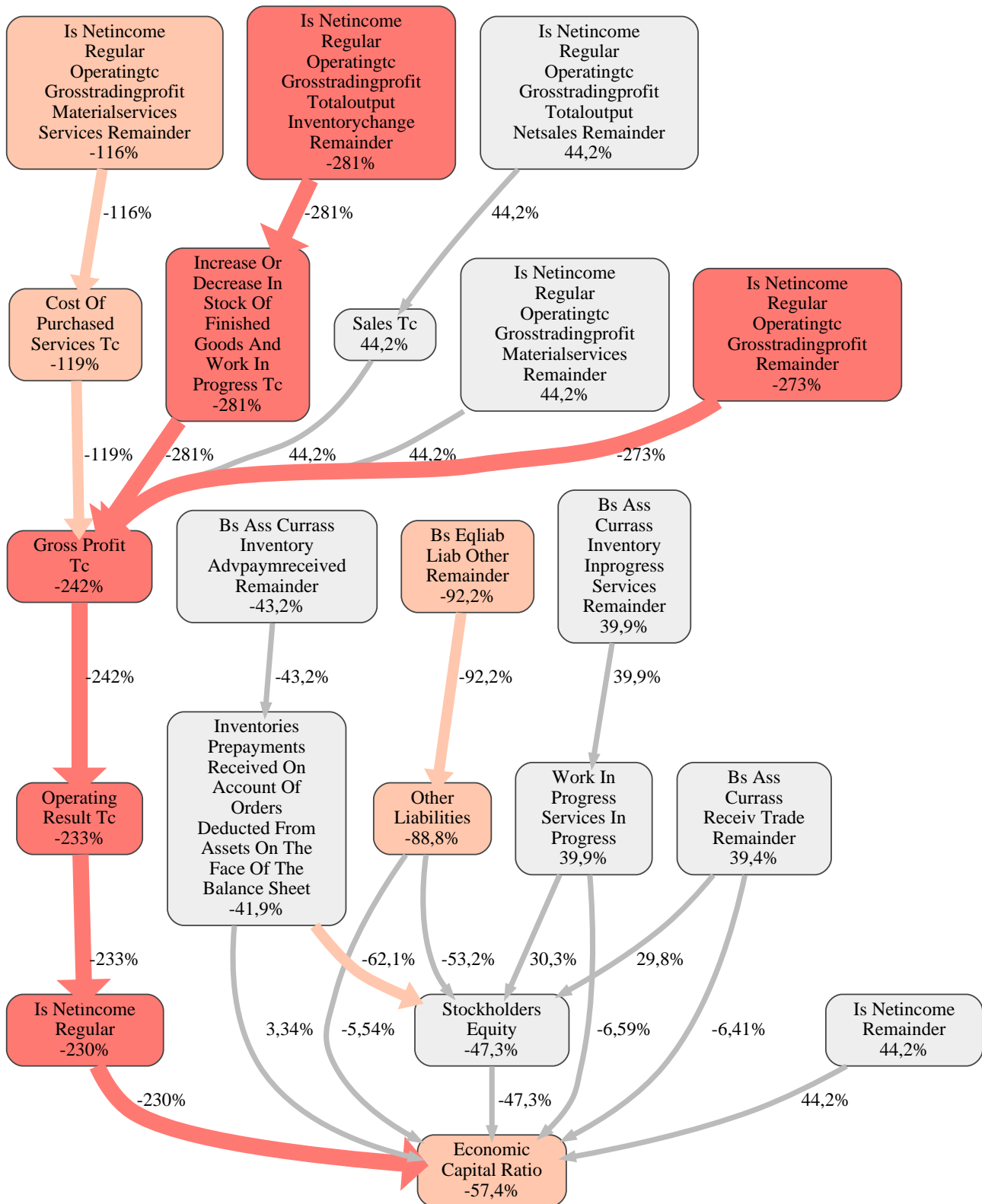

The relative strengths and weaknesses of Brunner Co Baugesellschaft mbH Co München are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Brunner Co Baugesellschaft mbH Co München compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, increasing the Economic Capital Ratio by 44% points. The greatest weakness of Brunner Co Baugesellschaft mbH Co München is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Inventorychange Remainder, reducing the Economic Capital Ratio by 281% points.

The company's Economic Capital Ratio, given in the ranking table, is 44%, being 57% points below the market average of 102%.
