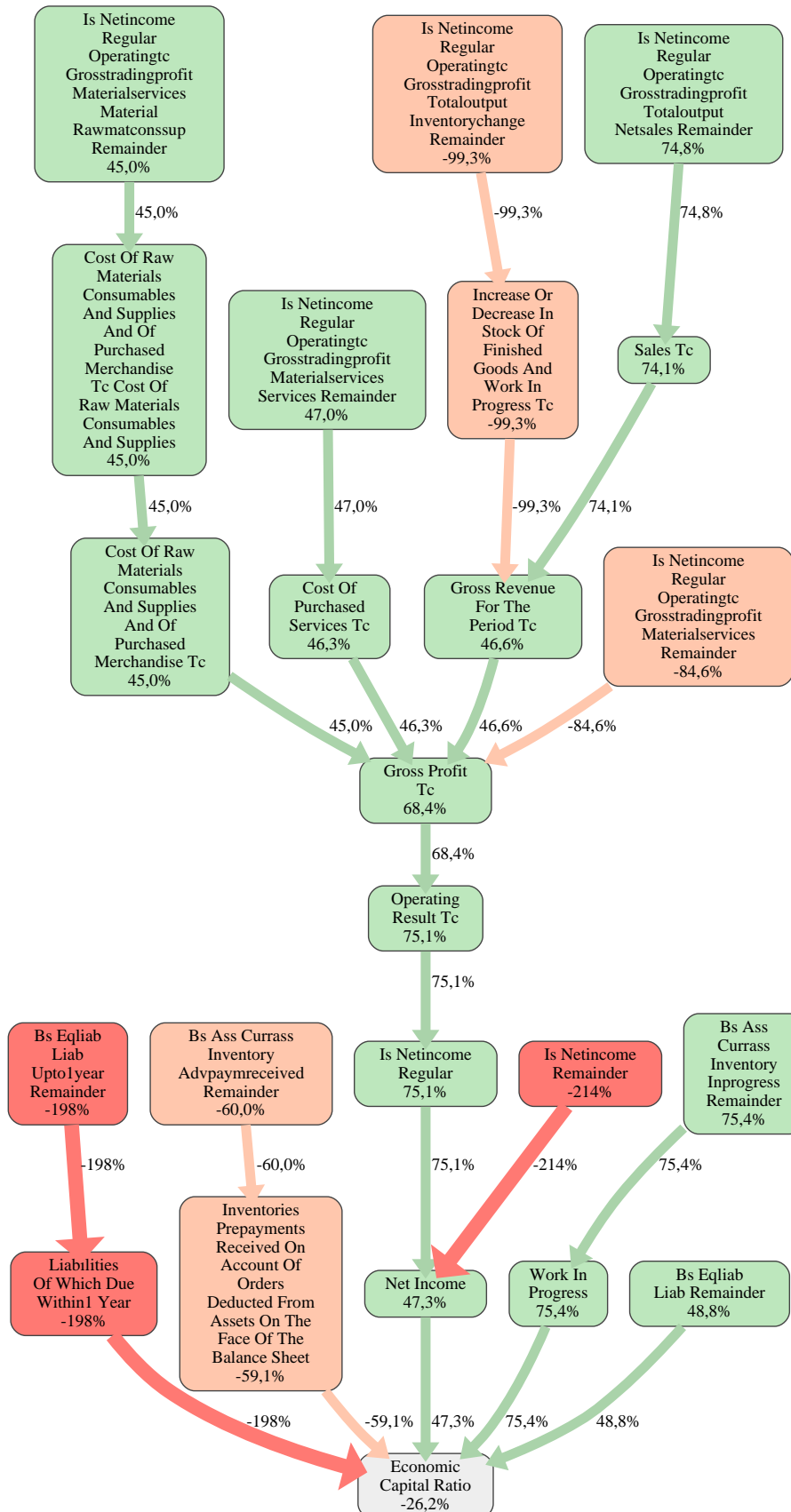

The relative strengths and weaknesses of Dipl Ing Emil Hönninger GmbH Co Bauunternehmung KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Dipl Ing Emil Hönninger GmbH Co Bauunternehmung KG compared to the market average is the variable Bs Ass Currass Inventory Inprogress Remainder, increasing the Economic Capital Ratio by 75% points. The greatest weakness of Dipl Ing Emil Hönninger GmbH Co Bauunternehmung KG is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 214% points.

The company's Economic Capital Ratio, given in the ranking table, is 75%, being 26% points below the market average of 102%.
