



The relative strengths and weaknesses of Helmut Kallage Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Helmut Kallage Bauunternehmen GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 135% points. The greatest weakness of Helmut Kallage Bauunternehmen GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 972% points.

The company's Economic Capital Ratio, given in the ranking table, is 135%, being 34% points above the market average of 102%.
