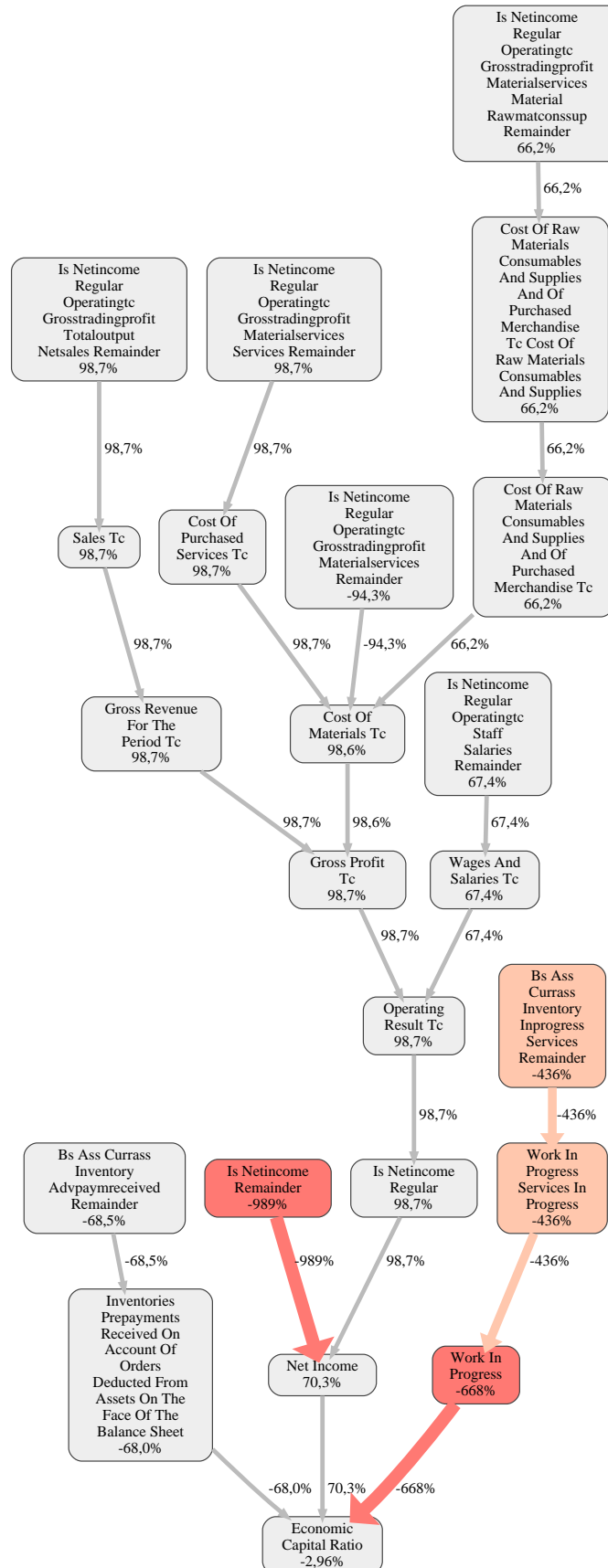

The greatest strength of Bauunternehmung Hofschröder GmbH Co KG compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 99% points. The greatest weakness of Bauunternehmung Hofschröder GmbH Co KG is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 989% points.

The company's Economic Capital Ratio, given in the ranking table, is 99%, being 3,0% points below the market average of 102%.
