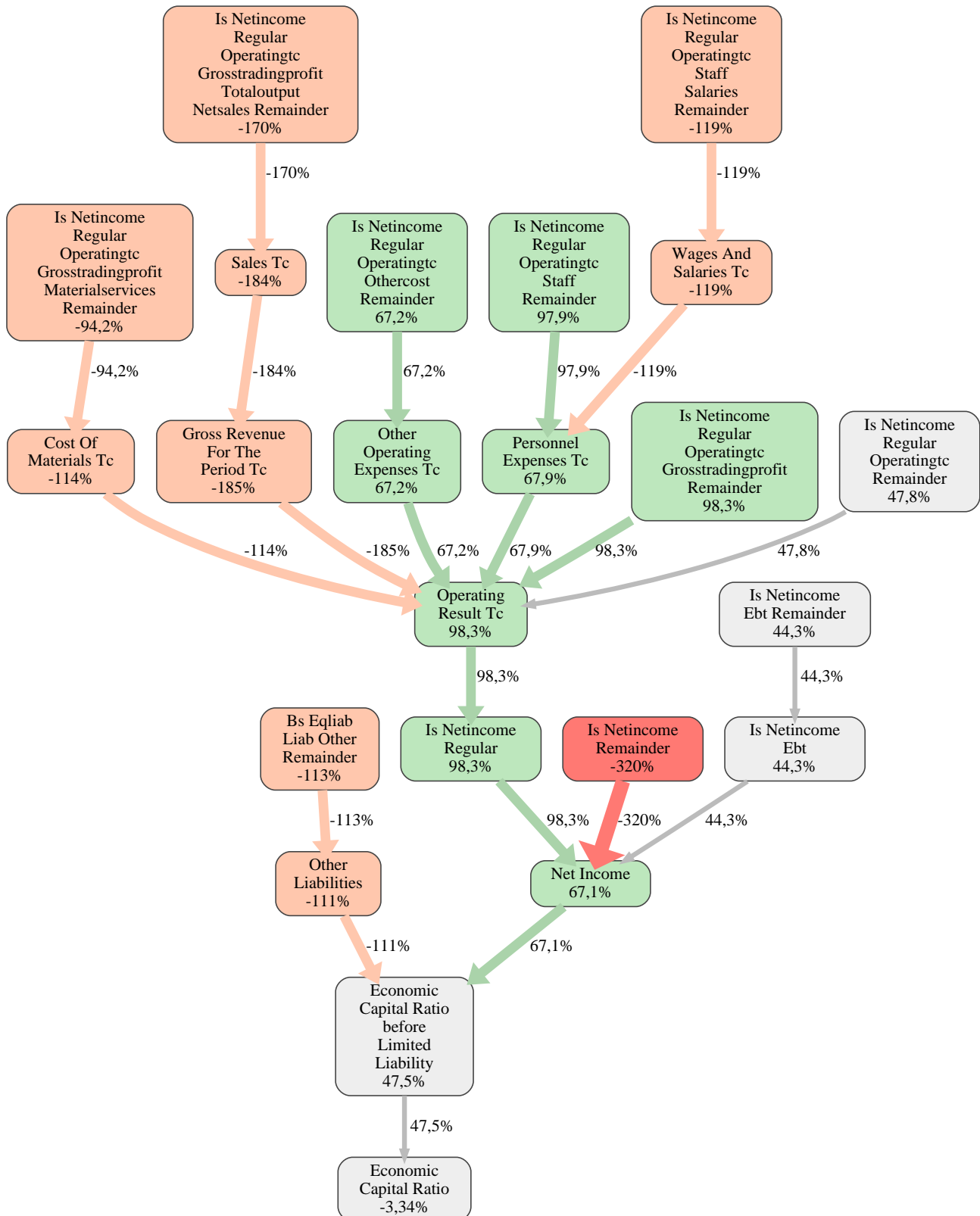

The greatest strength of Fertighaus Weiss GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, increasing the Economic Capital Ratio by 98% points. The greatest weakness of Fertighaus Weiss GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 320% points.

The company's Economic Capital Ratio, given in the ranking table, is 98%, being 3,3% points below the market average of 102%.
