



The relative strengths and weaknesses of Gustav Eppe Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gustav Eppe Bauunternehmung GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 57% points. The greatest weakness of Gustav Eppe Bauunternehmung GmbH is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 1.043% points.

The company's Economic Capital Ratio, given in the ranking table, is 57%, being 45% points below the market average of 102%.
