



The relative strengths and weaknesses of Gottfried Stehnke Bauunternehmung GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gottfried Stehnke Bauunternehmung GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 172% points. The greatest weakness of Gottfried Stehnke Bauunternehmung GmbH Co KG is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 976% points.

The company's Economic Capital Ratio, given in the ranking table, is 172%, being 70% points above the market average of 102%.
