



The relative strengths and weaknesses of Hentschke Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hentschke Bau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 94% points. The greatest weakness of Hentschke Bau GmbH is the variable Work In Progress, reducing the Economic Capital Ratio by 36.221% points.

The company's Economic Capital Ratio, given in the ranking table, is 94%, being 7,3% points below the market average of 102%.
