

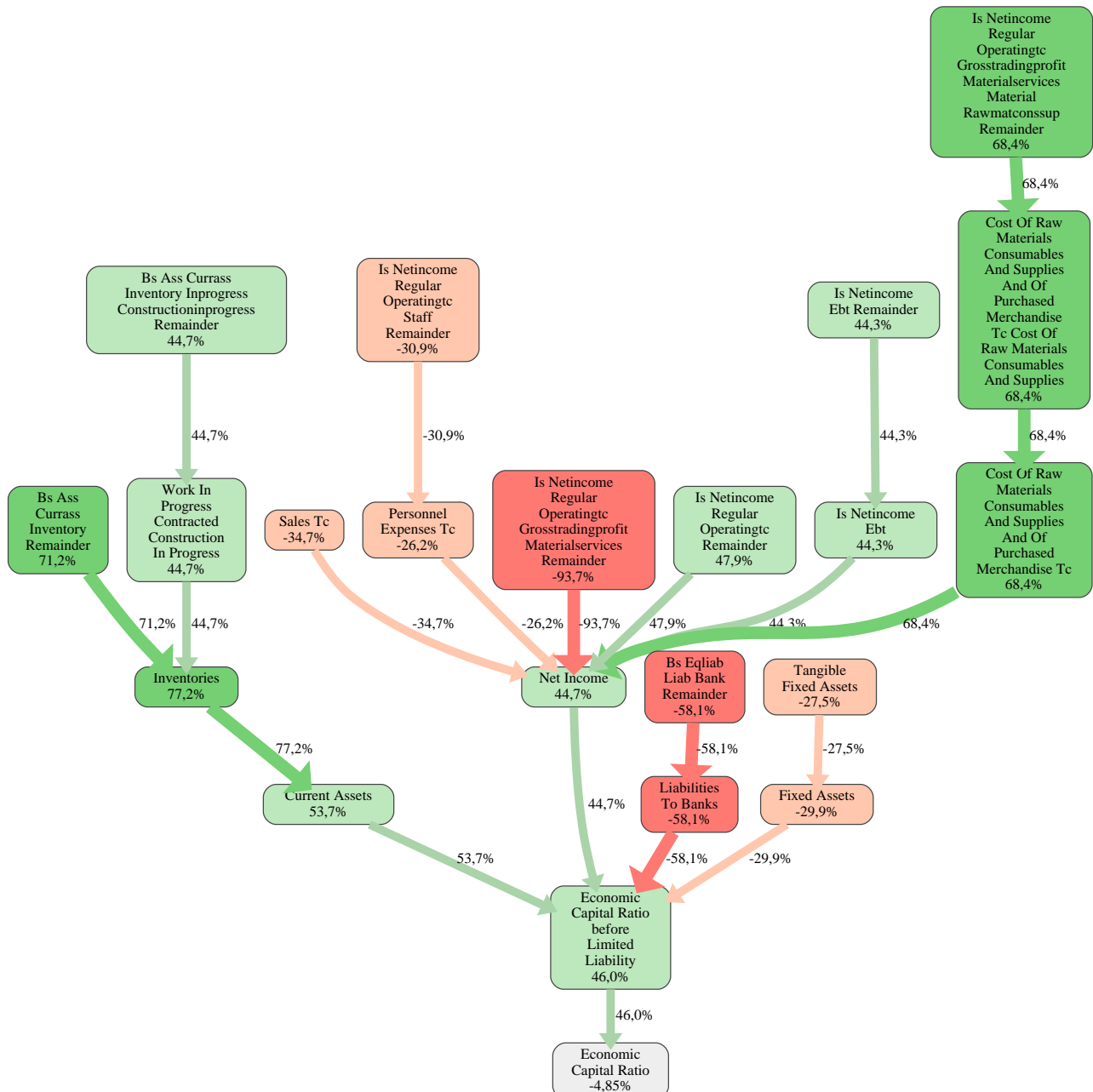

The relative strengths and weaknesses of Werner Wohnbau GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Werner Wohnbau GmbH Co KG compared to the market average is the variable Inventories, increasing the Economic Capital Ratio by 77% points. The greatest weakness of Werner Wohnbau GmbH Co KG is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, reducing the Economic Capital Ratio by 94% points.

The company's Economic Capital Ratio, given in the ranking table, is 97%, being 4,9% points below the market average of 102%.
