



The relative strengths and weaknesses of Giebel Hoch und Tiefbau AG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Giebel Hoch und Tiefbau AG compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 72% points. The greatest weakness of Giebel Hoch und Tiefbau AG is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, reducing the Economic Capital Ratio by 100% points.

The company's Economic Capital Ratio, given in the ranking table, is 130%, being 28% points above the market average of 102%.
