



The relative strengths and weaknesses of Rensch GmbH Co Grundstücksverwaltung KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Rensch GmbH Co Grundstücksverwaltung KG compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 146% points. The greatest weakness of Rensch GmbH Co Grundstücksverwaltung KG is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 756% points.

The company's Economic Capital Ratio, given in the ranking table, is 146%, being 44% points above the market average of 102%.
