



The relative strengths and weaknesses of Faber Schnepf Hoch und Tiefbau GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Faber Schnepf Hoch und Tiefbau GmbH Co KG compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 54% points. The greatest weakness of Faber Schnepf Hoch und Tiefbau GmbH Co KG is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 98% points.

The company's Economic Capital Ratio, given in the ranking table, is 63%, being 38% points below the market average of 102%.
