The greatest strength of Hanova Services GmbH compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 48% points. The greatest weakness of Hanova Services GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 506% points.

The company's Economic Capital Ratio, given in the ranking table, is 48%, being 54% points below the market average of 102%.
