

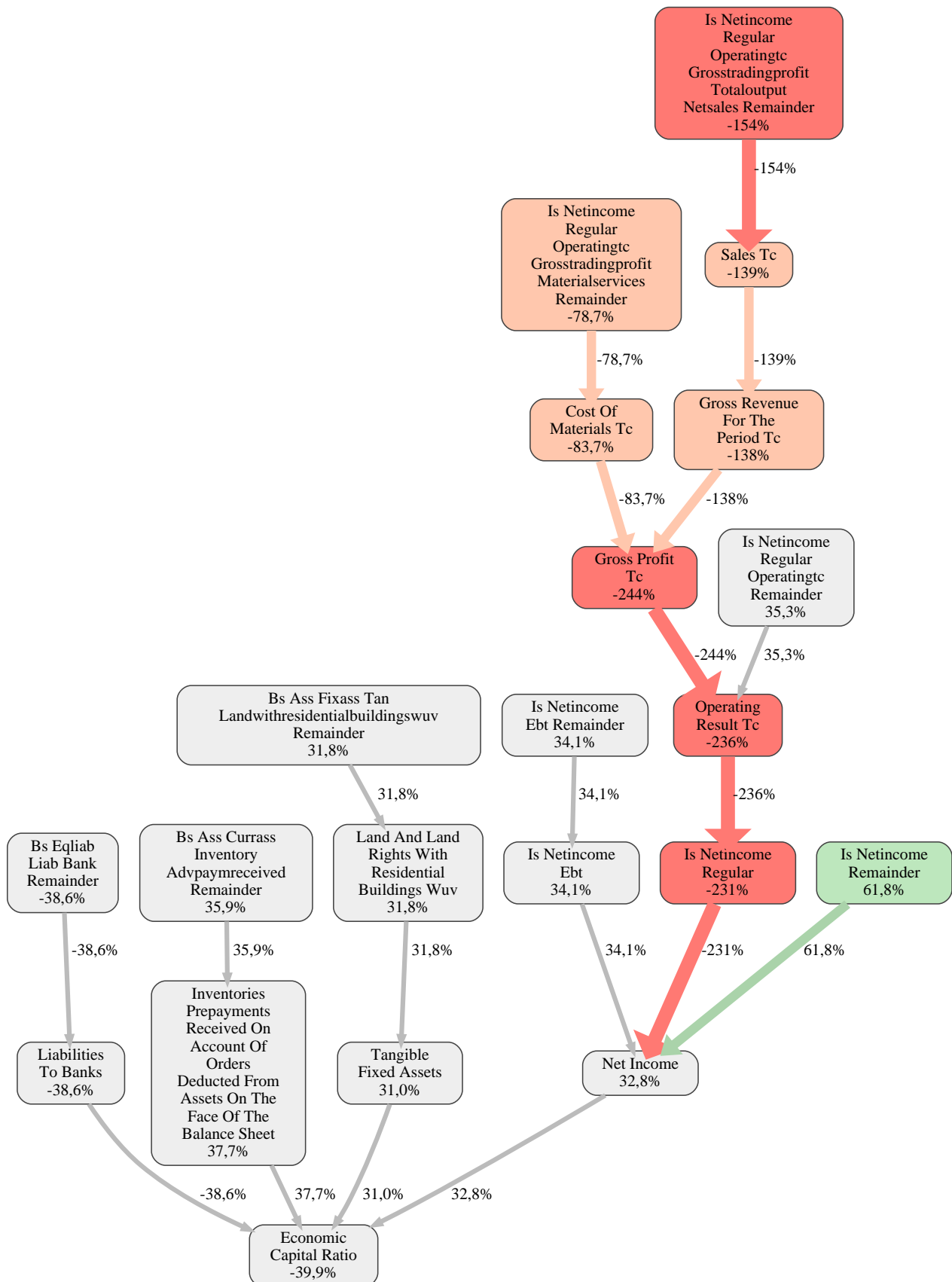

The relative strengths and weaknesses of Herner Gesellschaft für Wohnungsbau mbH HGW are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Herner Gesellschaft für Wohnungsbau mbH HGW compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 62% points. The greatest weakness of Herner Gesellschaft für Wohnungsbau mbH HGW is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 244% points.

The company's Economic Capital Ratio, given in the ranking table, is 62%, being 40% points below the market average of 102%.
