



The relative strengths and weaknesses of Wohnbau Service Bonn GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnbau Service Bonn GmbH compared to the market average is the variable Inventories Prepayments Received On Account Of Orders Deducted From Assets On The Face Of The Balance Sheet, increasing the Economic Capital Ratio by 26% points. The greatest weakness of Wohnbau Service Bonn GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 134% points.

The company's Economic Capital Ratio, given in the ranking table, is 29%, being 72% points below the market average of 102%.
