The greatest strength of Gesobau Wohnen GmbH Co KG compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 47% points. The greatest weakness of Gesobau Wohnen GmbH Co KG is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 231% points.

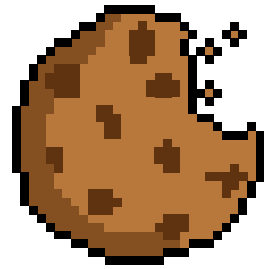
The company's Economic Capital Ratio, given in the ranking table, is 47%, being 55% points below the market average of 102%.
