



The relative strengths and weaknesses of Röhrsdorfer Wohnungsbauförderungsgesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Röhrsdorfer Wohnungsbauförderungsgesellschaft mbH compared to the market average is the variable Bs Ass Fixass Tan Landwithresidentialbuildingswuv Remainder, increasing the Economic Capital Ratio by 22% points. The greatest weakness of Röhrsdorfer Wohnungsbauförderungsgesellschaft mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 148% points.

The company's Economic Capital Ratio, given in the ranking table, is 22%, being 79% points below the market average of 102%.
